I plan to write an MA thesis because I seek to examine and analyze the scholarship that I read in my first two semesters in more depth and detail. In other words, I want to develop a qualitative description of political rhetoric in El Salvador, using the analytical approaches I first learned in CMJ 525, Propaganda and Political Communication (Fall 2023), while combining that approach with the in-depth analysis (using grounded theory) that will be submitted for my final project in CMJ 540: Social Media and Digital Culture, where I reviewed people's response on social media to the president's orders to stop commemorating the signing of the peace accords in 1992.

I'm currently enrolled in CMJ 604: Qualitative Communication Research Methods (Spring 2024) where I'm learning about reflexivity, which I may also incorporate into my thesis. Furthermore, I plan to employ (if I can) what I'm developing in SPI: 590, Migration and Displacement, where I intend to analyze the discourse of the Salvadoran government when addressing our diaspora in the United States. For that project, I will be using the State-sponsored newspaper "Diario El Salvador" as a primary source.

I plan to meet regularly with Professor XXX to complete the prospectus for the committee, and to start pursuing my thesis research plan over this summer.

As you will see in more detail below, I plan to develop a prospectus by August and write my first chapters between October and November 2024, so they can be reviewed by my advisor in December and by the rest of the committee in the beginning of 2025. My goal is to defend my thesis in April in order to graduate in May.
